| 42 | 15.9.53 | 13th | Committee on Rules of Procedure and Privileges | Instruction to the Committee on Rules of Procedure and Privileges to consider whether a Substitute can replace a deceased Representative. |
| 43 | 18.9.53 | 16th | Committee on Legal and Administrative Questions | Request to the Committee for an Opinion on the interpretation of Article 21 of the Convention on Human Rights and, in particular, of the three following points : (a) Nomination of members of the European Commission of Human Rights by States which have not yet ratified the Convention; (b) Role of the Bureau specifically mentioned in Article 21, which cannot be identical with the role of the Secretary-General; (c) Nature and duration of the functions of the members of the Commission and fixing of their emoluments accordingly. |
| 44 | 18.9.53 | 16th | Committee on Social Questions | Direction to the Committee on Social Questions to continue its study of questions which could be usefully included in the programme of social policy, particularly those relating to the ratification of other International Labour Conventions. |
| 45 | 22.9.53 | 19th | Secretariat-General | Instruction to the Secretariat-General to transmit to N. A. T. O. Resolution n° 33 concerning the progress achieved in the field of European defence. |
| 46 | 23.9.53 | 21st | Committee on Legal and Administrative Questions | Instruction to the Committee on Legal and Administrative Questions to keep the question of the simplification of frontier formalities for travellers under review and to submit in due course any further recommendations it considers desirable. |
| 47 | 23.9.53 | 21st | Bureau of the Consultative Assembly | Instruction to the Bureau : (a) to transmit the Resolution 36 and the report of the Committee on Economic Questions as soon as possible to the Conference of European Ministers of Transport; (b) to inform the Conference of European Ministers of Transport that a delegation from the Assembly is prepared to present its comments on this resolution orally to this Conference, and its views on the relations to be established between the Conference and the Council of Europe, as the general framework of European policy. |
| 48 | 24.9.53 | 22nd | Special Committee on Municipal and Regional Affairs | Instruction to the Special Committee on Municipal and Regional Affairs to continue the work it had undertaken of ensuring the constant presence of the Council of Europe in intercommunal European life, by demonstrating to local authorities the extent of the assistance that the Council of Europe is able to furnish in the attainment of their common aims with the hope of obtaining in return the effective aid of the local authorities in the propagation of the European idea. |
| 49 | 24.9.53 | 22nd | Secretariat-General | Instruction to the Secretariat-General to follow the development of the question of the abolition of customs barriers and trade restrictions and decision to keep the question on its Agenda. |
| 50 | 25.9.53 | 23rd | Special Committee to deal with the question of the Greek Earthquake Victims and Special Committee on municipal and Regional Affairs | Instruction to : (a) the Special Committee to deal with the question of the victims of the Greek earthquake disasters to keep in touch with the work carried out by the Council of Europe on behalf of the victims of the Greek disasters and to report to the Assembly. (b) the Special Committee on Municipal and Regional Affairs to launch an appeal to the municipalities of Europe to adopt towns or villages in the devastated areas of Greece. |
| 51 | 25.9.53 | 24th | Secretariat-General | Instructed the Secretariat under the supervision of the Committee on Rules of Procedure and Privileges to issue a revised edition of the Rules incorporating the Amendments agreed to by the Assembly (Doc. 213). |
