Examination of credentials of representatives and substitutes

Report on credentials

President of the Assembly

1. In accordance with Rule 6, paragraphs 1 and 4, of the Rules of Procedure, the President of the Assembly has received credentials of representatives and substitutes for the fourth part of the 2015 Ordinary Session of the Assembly, which have been transmitted in due form by the competent authorities of member States.
2. The Assembly is called upon to take a decision on the ratification of the credentials of the representatives and substitutes whose names are given below.
3. **Armenia** has appointed a new representative following the resignation of Ms Arpine Hovhannisyan.
4. **Austria** has appointed a new substitute following the resignation of Mr Edgar Mayer.
5. The **Czech Republic** has appointed a new substitute following the resignation of Mr Simeon Karamazov.
6. **Denmark** has appointed a new delegation following parliamentary elections.
7. **France** has appointed a new representative following the resignations of Mr Jean-Marie Bockel and Ms Colette Langlade.
8. **Germany** has appointed a new representative to fill a vacant seat.
9. **Italy** has appointed two new substitutes, and two substitutes have become representatives, following the resignations of Mr Alessandro Bratti and Mr Sandro Gozi.
10. **Slovenia** has appointed a new representative following the resignation of Ms Andreja Katič.
11. **“The former Yugoslav Republic of Macedonia”** has appointed a new representative and a new substitute to fill two vacant seats.
12. **Turkey** has appointed three new representatives to fill three vacant seats.
13. In the case of objection or justified contestation, the contested credentials shall be referred without debate to the appropriate committee, which shall report back to the Assembly in accordance with Rules 7 and 8 of the Rules of Procedure.
