Letter from Mr Patrick Engelberg, Ambassador of Luxembourg to the Council of Europe, to Ms Chatzivassiliou-Tsovilis, Secretary General of the Parliamentary Assembly, dated 27 October 2023.

2. Information on national selection procedure for the position of a judge of the European Court of Human Rights

The national selection procedure in Luxembourg is largely based on the guidelines of the Committee of Ministers of the Council of Europe of 28 March 2012 on the selection of candidates for the post of judge at the European Court of Human Rights and its explanatory memorandum, which includes good practice in other Council of Europe member countries.

2.1. Call for applications

On 14 January 2023, a call for applications was published in Luxembourg's three largest daily newspapers: Luxemburger Wort, Tageblatt and Journal.

The call for applications was also published in the Luxembourg Official Journal, more specifically in the series known as Mémorial B (No. 245 of 25 January 2023).

It was also distributed electronically to the Luxembourg bar, the magistracy, notaries and bailiffs.

The call for applications was inspired by the guidelines of the Committee of Ministers of the Council of Europe of 28 March 2012 on the selection of candidates for the position of judge at the European Court of Human Rights.

Candidates had to:

- be jurists of high moral character, in accordance with Article 21.1 of the Convention, who possess the qualifications required for appointment to high judicial office in their country or who are of recognised competence;
- have practical legal experience and knowledge of the Luxembourg legal system and international public law, particularly in the field of human rights;
- be proficient in the national language and one of the official languages of the Council of Europe (French or English), with at least a passive knowledge of the other language. Proficiency in the two languages of the Council of Europe will be considered an advantage.

The applications were submitted to a national selection committee. It invited the candidates who met the requirements to an interview, during which it examined not only their qualifications and experience, as well as their legal and linguistic skills, but also their suitability for judicial office within a collegiate body, including their management skills. The interviews took place at the Ministry of Justice in Luxembourg on 7 June 2023.

Candidates were invited to indicate in their application why, in their own judgement, they were suitable for this role. The curriculum vitae attached to the application must have been drawn up in one of the official languages of the Council of Europe on the basis of the model, the electronic version of which can be found at the following address: <http://assembly.coe.int/CommitteeDocs/2009/IVIodelCVFR.doc>.

Following this call for applications, the Ministry of Justice received seven applications for the position of judge at the European Court of Human Rights in respect of Luxembourg, including one female application.

2.2. Setting up the selection body

On 2 February 2023, the Minister of Justice, drawing inspiration from the above-mentioned guidelines and their explanatory memorandum, sent an official letter to the institutions and persons whom she intended to have sit on a national selection committee for candidates for the position of judge at the European Court of Human Rights in respect of Luxembourg.

In this letter, the selection procedure was explained in full.

By Ministerial Decree of 24 April 2023, amended by the Decree of 26 May 2023, which has as its legal basis the European Convention on Human Rights, the Rules of the European Court of Human Rights, [Resolution 1646 \(2009\)](#) of the Parliamentary Assembly of the Council of Europe on the nomination of candidates and election of judges to the European Court of Human Rights, the Resolution of 23 September 2009 of the Committee of Ministers of the Council of Europe on the status and conditions of service of judges at the European Court of Human Rights and the guidelines of 28 March 2012 of the Committee of Ministers of the Council of Europe concerning the selection of candidates for the post of judge at the European Court of Human Rights, the Minister of Justice has appointed the following persons as members of the Luxembourg Selection Committee:

- Maître Christian BILTGEN, President of the Diekirch Bar;
- Mr Francis DELAPORTE, President of the Administrative Court;
- Mr Patrick ENGELBERG, Permanent Representative to the Council of Europe;
- Mr Fernand ETGEN, President of the Chamber of Deputies;
- Ms Christine GOY, Secretary General at the Ministry of Justice;
- Ms Katalin LIGETI, Professor at the University of Luxembourg;
- Mr Roger LINDEN, President of the Superior Court of Justice;
- Ms Claudia MONTI, Mediator;
- Mr Gilbert PREGNO, Chairman of the Consultative Commission on Human Rights;
- Maître Pit RECKINGER, President of the Luxembourg Bar;
- Ms Martine SOLOVIEFF, General State Prosecutor.

The secretariat was provided by Ms Nancy Carier, Advisor at the Ministry of Justice, appointed by the same ministerial decree for this purpose.

Mr Roger Linden, Chairman, convened the Selection Committee before receiving the candidates in order to prepare for the interviews. Maître Pit Reckinger, President of the Luxembourg Bar, was excused.

The standardised interview outline drawn up in 2014, when the selection procedure was introduced, was analysed and the Committee members agreed on the topics to be covered during the interviews.

It was decided that the language test would be carried out by means of oral questions in English and French.

The Selection Committee examined and validated all the applications received by the Ministry of Justice within the deadline.

It was also decided to have candidates sign a declaration of honour with the following wording:

"I, the undersigned, declare on my honour: (1) that, in the event of my election as a judge of the European Court of Human Rights, I undertake not to engage, during my term of office, in any activity which is incompatible with the requirements of independence, impartiality or availability required for a full-time activity;

(2) that I have never said, written or done anything which, if it were made public, might be prejudicial to the honour of the European Court of Human Rights."

As in 2014, candidates were asked to bring a recent extract from their criminal record to the interview.

The Chairman of the Selection Committee also asked all the members of the Selection Committee whether there was any conflict of interest concerning any of the candidates. All Committee members declared that they had no such conflict of interest.

2.3. Interviews with candidates

The Selection Committee's interviews with the candidates took place on 7 June 2023, under the chairmanship of Mr Roger Linden.

The secretariat was provided by Ms Nancy Carier, Adviser at the Ministry of Justice.

At the beginning of the interview each candidate handed in a recent extract from his/her criminal record and signed a declaration on his/her honour stating that if elected to the position of judge at the European Court of Human Rights, he/she undertakes not to engage, during his/her term of office, in any activity which is incompatible with the requirements of independence, impartiality or availability required for full-time office and that he/she has never said, written or done anything which, if it were to be made public, might be prejudicial to the honour of the European Court of Human Rights.

The interviews lasted approximately 30 minutes per candidate and during these interviews a language test was carried out by conducting part of the interview in English.

Following the interviews with the seven candidates, the Selection Committee deliberated and the members of the committee voted by secret ballot, with each member being able to mark the names of three candidates on the ballot paper.

Following this vote, the candidates with the highest number of votes were, in alphabetical order:

- Mr Jörg GERKRATH
- Ms Marie-Jeanne KAPPWEILER
- Mr Stéphane PISANI.

This list, together with the names of the other candidates, was submitted to the Minister of Justice, who endorsed the list adopted by the National Selection Committee.
