## Questions to be included in the Agenda of the Consultative Assembly

Committee of Ministers

1. Supplementary Report of the Committee of Ministers, and Progress Report of the Standing Committee.
2. Report transmitted to the Council of Europe by the Organisation for European Economic Co-operation.
3. Progress achieved in the sphere of European defence (Committee on General Affairs).
4. Rôle of the Council of Europe in the new pattern of organisation of Europe (Committee on General Affairs).
5. Changes in the political structure of Europe necessary to achieve a greater unity among the Members of the Council of Europe and to bring about effective co-operation in the various fields specified in Article 1 of the Statute (Committee on General Affairs).
6. Aims and prospects of European Policy within the framework of the Council of Europe (Committee on General Affairs).
7. Improvements to be made in the Rules of Procedure of the Assembly (Committee on Rules of Procedure and Privileges).
8. Appointment of a Committee on Municipal and Regional Affairs (Committee on Rules of Procedure and Privileges).
9. Removal of customs barriers and trade restrictions in Europe (Committee on Economic Questions).

17. Conclusion of a European Convention on Extradition, in accordance with the desire of all the Members for common action in the legal field (Committee on Legal and Administrative Questions).
18. Ways and means of improving the publicity given to the Council of Europe in European non-Member States (Special Committee to watch over the interests of European nations not represented in the Council of Europe).



19. Establishment of a European linguistic community based on the application of Anglo-French bilingualism (Committee on Cultural and Scientific Questions).
20. Ways and means of encouraging the international circulation of books, objects of art and all media of public information or education (Committee on Cultural and Scientific Questions).
21. Request to the International Olympic Committee to consider any suggestions which would enable political exiles to take part in the Olympic Games in future years (Special Committee to watch over the interests of European nations not represented in the Council of Europe).
22. Methods of encouraging, developing and co-ordinating investment and credit for the benefit of European industry (Committee on Economic Questions).
23. Issue of a collective loan for European defence (Committee on Economic Questions).
24. Measures calculated to solve, simultaneously and in one general plan, the problem of the unequal balance of trade between Europe and the United States, and the economic problem of the underdeveloped countries (Committee on Economic Questions).
