## Examination of credentials

### Report

Credentials Committee

Rapporteur: Mr Henri C. J. HEYMAN, Belgium

1. Meeting in accordance with the provisions of Rule 6 of the Rules of Procedure, the Committee appointed for the examination of credentials examined those of the Representatives and Substitutes to the Sixth Ordinary Session of the Consultative Assembly of the Council of Europe.

2. The credentials, certified and transmitted by the Ministers for Foreign Affairs, called for no comment in respect of the following Members: Belgium, Denmark, France, German Federal Republic, Greece, Iceland, Italy, Luxemburg, the Netherlands, Norway, Saar, Sweden and the United Kingdom.

3. The cases of the other Members call for the following comments:

- a. Ireland, which is entitled to four seats, has appointed only three Representatives;
- b. Turkey, entitled to ten seats, has appointed only six Representatives.

Consequently, of the 132 seats in the Assembly 5 are now vacant.

4. No objection having been raised, the Committee, unanimously proposes that the Assembly confirms the validity of the appointment of the following Representatives and Substitutes :
