Examination of credentials

Report

Credentials Committee

Rapporteur: Mr Georges BOHY, Belgium, Socialist Group

1.

1. Meeting in accordance with the provisions of Rule 6 of the Rules of Procedure, the Committee appointed for the examination of credentials examined those of the Representatives and Substitutes to the Seventh Ordinary Session of the Consultative Assembly of the Council of Europe.

2. The credentials, certified and transmitted by the Ministers for Foreign Affairs, called for no comment in respect of the following Members : Belgium, Denmark, Federal Republic of Germany, Greece, Iceland, Ireland, Italy, Luxembourg, the Netherlands, Norway, Saar, Sweden, Turkey and the United Kingdom.

3. France, which is entitled to 18 seats, has appointed only 17 Representatives. Consequently, of the 132 seats in the Assembly, one is now vacant.

4. No objection having been raised, the Committee unanimously proposes that the Assembly confirms the validity of the appointment of the following Representatives and Substitutes :
