of the meeting held in Strasbourg during the third part session 2026

The Committee on Social Affairs, Health and Sustainable Development, meeting in Strasbourg, on:

- **Tuesday, 23 June 2026, at 8.30 am**, with Ms Danuta Jazłowiecka (Poland, EPP/CD), oldest member present, in the Chair, as regards:
 - ***Violent pornography: a test for human rights*** (*Rapporteur for opinion: Mr Joseph O'Reilly, Ireland, EPP/CD*): considered and approved a draft opinion, as amended;
 - ***Access of migrants and refugees to healthcare*** (*Rapporteur for opinion: Ms Yuliia Ovchynnykova, Ukraine, ALDE*): considered and approved a draft opinion;

Russell, Senior Policy Officer, ILGA-Europe and authorised the rapporteur to carry out a fact-finding visit to Bocconi University in Milan (Italy);
